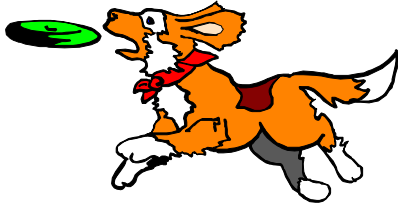

January 2010). Only fully paid up members are entitled to vote or put forward resolutions at the AGM.

- The PRESIDENTS CUP is awarded to the member who gains the highest number of points in Competitive obedience in not more than 10 Open or Championship Shows between 1 April 2009 and 31 March 2010.
- The DEVONMEAD TROPHY is awarded as above to the member gaining the second highest number of points as above.
- CLUB SPOONS are awarded to members gaining a 1st,2nd or 3rd at an Open Obedience Show

Members must attend at least 50% of training classes to qualify for the above 3 trophies. Points are awarded as follows: Challenge Certificate - 100, Reserve CC - 50, 1ST - 6, 2nd - 5, 3rd - 4, 4th - 3, 5th - 2 and 6th - 1. Please submit claims to the Secretary before the meeting.
